In lieu of the recent developments surrounding the above referenced park, more specifically parcels 19, 20, 21 and 22 as identified in the Department of City Planning's Greenpoint - Williamsburg Waterfront Rezoning documents [N 050110(A) ZRK], we would be remiss if we did not reiterate our position taken on December 6, 2004 and approved unanimously by our board.

We stated the following: "if not immediately acquired by the City and developed as public parkland, will remain vulnerable to private development of environmentally noxious uses and/or non-contextual residential development, severely exacerbating the community's drastic need for more public open space."

Your immediate attention to this matter will be greatly appreciated by the Greenpoint/Williamsburg community.
